1 SETTING INFORMATION

Vision and Values

Ark All Saints Academy is an inclusive school where all students are made to feel welcome and valued. Our Academy vision sets out to ensure that all students enjoy high quality learning experiences through which they are able to achieve their full potential irrelevant of their needs. Our inclusive ethos aims to encourage all students to be actively involved in their own learning. This involves valuing all students and staff equally and reducing barriers to learning and participation. Ark All Saints Academy aims to provide a rigorous and transformational education that prepares students for success at university and beyond.

Describe the Diverse Needs of the Community [e.g. school context from SEF]

Ark All Saints Academy (AASA) opened in September 2013. We are a Church of England and Ark sponsored academy whose values are Confidence, responsibility integrity and success. ~~It opened on the semi-demolished site of St Michael and All Angels Academy which closed in July 2013 due to falling pupil numbers. AASA is a smaller than average secondary school, with 593 scholars on roll.~~ The academy is part of the Ark Schools network of schools one of the top performing multi-academy trusts (average progress 8 of 0.16 across 18 schools in 18/19). Additionally, as a Church of England secondary school it is part of the Southwark Diocese Board of Education (SDBE). Our latest SIAMS (Section 48) inspection (2017) judged the academy to be Outstanding in every category. Since opening, the academy has built a strong reputation within the local community leading to oversubscription in Year 7 admissions for the past four years.

Over the past 8 years our focus has been creating an academy with a systematic way of working that ensures that all staff and scholars are able to be successful. The systems and routines have been revised over the years to enable the academy to grow and develop from housing one year group to five with a growth in the number of staff. Over the years we have set up from scratch assessment processes, reporting to parents, Parents' evenings, scholar voice etc. ~~Each department has been grown over time and many of our middle leaders started in roles with less responsibility. Some were teaching partners or ECTS when they first began.~~

Within the context of our school, disadvantaged groups are represented significantly higher than the national average. Most scholars come from the local areas of Camberwell, Walworth and Peckham which has diverse ethnic groups. This is reflected in the intake of the Academy. This includes scholars of South American, Southeast Asian, and West African origin as well as many from inside the EU. Southwark is ranked as having the 6th highest unemployment rates in London 17-20. Compared to national averages, crime is high in the area with Southwark being ranked 2nd out of the 35 London police boroughs for total crimes (2018/19). ~~We are also aware that some of our families are known to the Police.~~ Camberwell is amongst the 20% most deprived neighbourhoods in the country. A higher than national average number of scholars speak English as an additional language (34% of all current scholars).

The proportion of scholars receiving pupil premium are higher than national (49%).

~~In 2020 to 2021 for the first time since the Academy opened, our attendance fell below 96% to 93.2% and PA of 21.3% We are above the Ark average for attendance. We have the second highest attendance of the South London Ark schools, and the highest attendance of the Southwark Ark schools. We continued to promote good attendance whilst working within Covid measures. We have no scholars who refuse to attend or are considered 'missing'. Suspensions have reduced year on year, although we saw a slight increase in 2020-21 when 53 scholars were suspended. This is a suspension rate of 12.1 and included some scholars who were unable to manage within the covid safe behaviour policy. We chose to operate without isolation rooms or an internal unit due to Covid restrictions. The number of scholars who had 1+ suspensions is 11.3%. We have had no permanent exclusions for 3 years. The academy is an active member of the Southwark managed move forum to help reduce the number of permanent exclusions in the borough. We accept more managed move scholars than leave for other schools.~~

Consultation to inform Audit/Action Plan: School staff, governors and support services

Consultation with stakeholders is an ongoing process, involving both formal and informal procedures. Regular reviews take place with support services to evaluate needs and provisions.

Views of Parents

Parental views are formally solicited at termly meetings. Parents are also encouraged to arrange to see staff if they have particular concerns (or complaints). Several members of staff are employed specifically because they speak community languages.

Views of Children and Young People

Pupils are regularly consulted, including through personal reviews and student voice polling.

2 PURPOSE

Ark all Saints Academy is committed to providing a fully accessible environment which values and includes all pupils, staff, parents and visitors regardless of their education, physical, sensory, social, spiritual, emotional and cultural needs. We are committed to challenging negative attitudes about disability and accessibility and to developing a culture of awareness, tolerance and inclusion. We aim to as far as possible to remove those barriers which make it hard for a person who has difficulties with:

- Physical Co-ordination
- Mobility
- Continence
- Ability to lift, carry or move heavy objects
- Speech, hearing or vision
- Memory or ability to learn, concentrate or understand
- Perceiving risk of physical danger

All pupils should be able to take part in the day to day life of the school and benefit from the learning experiences we provide

Overall, the Accessibility Plan will contain relevant actions to:

- Improve access to the physical environment of the school, adding specialist facilities as necessary. This covers improvements to the physical environment of the school and physical aids to access education.
- Increase access to the curriculum for pupils with a disability, expanding the curriculum as necessary to ensure that pupils with a disability are as, equally, prepared for life as are the able-bodied pupils; (If the school fails to do this they are in breach of the Equality Act). This covers teaching and learning and the wider curriculum of the school such as participation in after-school clubs, leisure and cultural activities or school visits. It also covers the provision of specialist aids and equipment, which may assist these pupils in accessing the curriculum.
- Improve the delivery of written information to pupils, staff, parents and visitors with disabilities.

Examples might include hand-outs, timetables, textbooks and information about the school and school events. The information should be made available in various preferred formats within a reasonable time frame.

An Action Plan is attached in section 5 which relate to the three key aspects of accessibility. This plan will be reviewed and adjusted on an annual basis and or when appropriate. A new Accessibility Plan will be drawn up every three years.

We acknowledge that it is necessary to raise awareness of issues related to accessibility and to

provide appropriate training for staff and governors in the matter of disability discrimination.

The main priorities in Ark All Saints Academy's plan are as follows:

Increasing the extent to which disabled pupils can participate in the school curriculum

Ark All Saints Academy will endeavour to provide suitable access to a range of curriculum opportunities.

- The school will endeavour to provide suitable access to a range of curriculum opportunities
- Where necessary, guidance and support will be given by the SENCO
- Ark All Saints Academy have several Teaching assistants who are deployed by the schools SENCO to ensure the needs of students with a statement or Education, Health and Care Plan are being met.
- Ark All Saints Academy to facilitate services from a range of agencies for all pupils and their families.

Improving the physical environment of the school to increase the extent to which disabled pupils can take advantage of education and associated services

- The main building has two lifts each ensuring access for all pupils. The staffroom is accessible by lift for any staff with mobility needs or hidden disabilities.
- Excellent access to the main building with automatic front doors
- There is a meeting room and toilets within easy reach of the reception so we can easily accommodate wheel chair users and visitors with reduced mobility.
- Sport facilities that are located on the ground floor and access is step free.
- Lifts are provided to access classrooms on the first and second floor for any students and

school personnel with mobility needs.

- Ark All Saints Academy has disabled toilet facilities for pupils and for the use of disabled people using extended school services with grab handles for additional support and emergency cords to request help
- Ark All Saints Academy has disabled shower facilities with grab handles for additional support and emergency cords to request help.
